NO SSN MESSAGE STUDENT PERMIT APPLICATION INSTRUCTIONS

This application should only be used by licensed massage therapy schools who are enrolling students that do not hold a social security number.

APPLICATION FEE: \$25 (FEE IS NON-REFUNDABLE)

1. **Name** – Provide the students legal name in the spaces provided. (Last, First, Middle Name, Suffix) Examples of a suffix include Jr., Sr., and III. (Mr. is not a suffix.)
2. **Date of Birth** – Provide the students date of birth.
3. **Gender** – Select gender of the student.
4. **Student Social Security Number** – Select YES or NO to indicate if the student has been issued or assigned a Social Security Number by the Social Security Administration. If yes, provide the Social Security Number. Social Security Number disclosure is required by Section 231.302(c)(1) of the Texas Family Code to obtain a license. Your Social Security Number is subject to disclosure to an agency authorized to assist in the collection of child support payments. For more information regarding child support payments, contact the [Texas Attorney General](#).
5. **Student Mailing address and contact information** – Provide your current mailing address. This is the address where we will send you mail. This address can be a post office box. You can add the zip plus-4 to help the postal service deliver mail more efficiently and accurately. Provide a telephone number, including the area code, where we can reach you during the day. Provide your email address. By providing your email address you authorize the Texas Department of Licensing and Regulation (TDLR) to send licensing communications and required notices by electronic mail. The email address provided in this application will remain confidential except as permitted or required by law.
6. **Massage School Information** – Provide the name, school license number, and address of the massage school you will be attending.
7. **Program Type** – Provide the course type the student is enrolling in. Example (MT)
8. **Enrollment Date** – Provide the date the student enrolled in the massage school.
9. **Graduation from high school or obtained G.E.D** – Select YES or NO to indicate if you have graduated from high school or obtained you G.E.D. If YES, enter the high school's name, city, state, and date of graduation.
10. **Acknowledgement** – Carefully read the statement before you sign and date this application.
