TOW TRUCK ADD, DELETE, AND CHANGE FORM INSTRUCTIONS

The application must be completed and signed by the applicant. An application is not considered complete and will not be processed until all required items have been submitted. All information provided must be typed or printed in black ink. Attachments must be submitted on separate pieces of single-sided, 8½" x 11" paper. Use a paperclip to fasten all pages together, with the check or money order on top. **Do not use staples.**

DOCUMENTS SUBMITTED WITH YOUR APPLICATION WILL NOT BE RETURNED. KEEP A COPY OF YOUR COMPLETED APPLICATION, ALL ATTACHMENTS, AND YOUR CHECK OR MONEY ORDER.

1. TOW TRUCK COMPANY CERTIFICATE NUMBER - Write the certificate number of the tow truck company as it appears on the tow truck company certificate issued by TDLR.
2. NAME OF TOW TRUCK COMPANY - Write the full name of the tow truck company.
3. DBA - Write all assumed names or DBAs used by this business.
4. TOW TRUCK INFORMATION AND FEES - Enter required information for all tow trucks you are adding, deleting, or changing the tow type. Do not list trailers.
 - Designate if tow truck(s) you are adding, or changing the tow type for, will be used to perform incident management (IM) tows, private property (PP) tows, or consent tows (CT) by checking the appropriate box.
 - ◆ Tow trucks designated to perform IM tows can perform PP tows and CT tows.
 - ◆ Tow trucks designated to perform PP tows can also perform CT tows.
 - ◆ Tow trucks designated to perform CT tows can only perform CT tows.
 - Verify whether the tow truck is equipped to tow light-duty (LD) vehicles or heavy duty (HD) vehicles according to manufacturer's guidelines by checking the appropriate box. You must check one.
 - Verify if tow truck(s) is a car hauler or not, by entering Y for yes and N for no in the appropriate box. A car hauler is a tow truck that can haul three or more vehicles at one time.
 - If you check delete, the tow truck will be deleted and cannot be retrieved. No refunds or credit will be given.
5. SIGNATURE OF OWNER/REPRESENTATIVE - After carefully reading the statement, the authorized person must sign, provide a title, printed name, and date the form.
